NOTICE: Effective July 15, 2024, the Finance Charge method for Cash Advances will be the Average Daily

Balance (including current transactions). The Interest Charge on cash advances begins from the date you obtained the cash advance, or the first day of the billing cycle in which it is posted to your account, whichever is later. There is no grace period. A portion of the Interest Charges for a billing cycle is computed by applying the monthly Periodic Rate to the "average daily balance" of your account. To get the average daily balance, we take the beginning balance of your account each day, add any new purchases or cash advances, and subtract any payments, credits, non-accruing fees, and unpaid interest charges. This gives us the daily balance. Then we add up all the daily balances for the billing cycle and divide the total by the number of days in the billing cycle.

New Enhanced Debit Card Controls With Card Suite Lite App

Debit Cardholders will need to download and register with the Card Suite Lite App and create a new login name, password and add their debit card. Refer to the appropriate QR Code below to download the Card Suite Lite App to your phone. It is important that Debit cardholders set up new Card controls and alerts within the Card Suite Lite App. (The Card Suite Lite App replaces the former MobiMoney App)

New features from the Card Suite Lite App include:

- Enhanced card management that allows the user to archive or delete a card without deleting their user profile.
- Ability to set controls for contactless transactions.
- Ability to set spend limits globally, per day, or transaction.
- Ability to share card with trusted contacts.
- Additional merchant types further define user spending including shopping, gifts and donations, insurance, education and more.
- Enhanced registration security including One-Time Passcodes.
- Enriched merchant data that includes the merchant's name and logo.
- A record of all alerts and notifications, including all changes made in the app (e.g., Freeze/Unfreeze)
- Ability to add a picture to your in-app profile.
- Increased transaction details with enriched data.
